**ORDER**

2.The principal has applied for continuation of provisional affiliation to the above programmes for the academic year 2024-25 as per the paper read as (2) with renewed NOC ( read as (3)).

3. Inspection Commission was appointed vide UO read as (4), to verify the infrastructural and instructional facilities available in the College for conducting these programmes .

4.Inspection Commission submitted its reports vide paper read as (5) recommending Continuation of Provisional Affiliation for the three programmes .

5.Considering the above,Sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the programmes, as detailed below, for the academic year 2024-25 at Duxford College for Advanced Studies,Kalikavu,Malappuram.

6. Orders are issued accordingly subject to the terms and conditions specified thereunder:

1. The Principal shall strictly follow the syllabi available in the University website [www.uoc.ac.in](http://www.uoc.ac.in) for selecting complementary courses.
2. The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
3. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
4. In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
5. Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
6. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
7. The conduct of University Examinations of any sort including that of the SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
8. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
9. Admission to the next academic year shall be made only after obtaining prior permission from the University.
10. Violation of any of the above will lead to the cancellation of affiliation.
